2016 MUNICIPAL ELECTIONS

Council acknowledged information relating to the 2016 Local Government Elections slated for October 26, 2016, and Richard Dolezsar was appointed Returning Officer under the terms of the Local Government Elections Act. Nominations will open September 1, 2016 and final nomination day will be September 21, 2016. Council will be considering a Bylaw to require Criminal Record Checks to be submitted with all nominations.

OH & S REPORT – MAY 30th – SHOP PROJECT CONTRACTOR

The May 30, 2016 OH & S Officer's Report was acknowledged respecting the Shop expansion project and Council accepted the recommendation that all third party Town contracts be issued subject to required compliance of applicable Health and Safety legislation.

ONE (1) TON TRUCK

Authorization was given to Director of Public Works to secure proposals for Council's consideration on an appropriate work vehicle to replace the 1992 GMC Regular Cab 1 ton.

CEMETERY BYLAW – GRAVE COVERS

Council acknowledged provisions in the existing Cemetery Bylaw No. 2-81, Section 7 respecting care of graves and potential removal of grave covers and other items in disrepair, and notice will be given to next of kin whenever possible prior to work being completed.

WASTE DISPOSAL SITE CONTRACT

Council acknowledged the draft copy of the Waste Disposal Site Operator's Contract and approved amended terms to be implemented into wording prior to finalization. Effective July 1, 2016 proposed hours are Sunday, Monday, Tuesday and Thursday 12:00 noon to 8:00 p.m. The finalized hours and other regulations will be issued in a Public Notice.

HANDIVAN DRIVER

The Town will continue to advertise the Handivan Driver's Contract until the position is filled.

R.M. of HUDSON BAY #394 – OCP & ZONING BYLAW

Council acknowledged receipt of the draft copy of the R.M. Official Community Plan and Zoning Bylaw.

HERITAGE PARK – COMMUNITY EVENT PERMIT

Council approved issuance of a Community Event Permit to the Hudson Bay Heritage Park Inc. for a July 1, 2016 Canada Day Beer Gardens from 2:00 p.m. to 7:00 p.m. on site at Pt SE8-45-3-W2.

POOL POLICY UPDATE

The Pool Policy amendment was approved to address the hiring of Junior Guards at ages of 14 to 16 years, subject to outlined qualifications, required permissions, training and supervision.
